

Harrow College is one of the most popular colleges in Northwest London and we would like to give you an opportunity to secure your place on the course of your choice.

Please bring the following documents with you when you come to enrol:

- Identification Documents – Passport OR UK Birth Certificate
- Residency Documents – If you became a resident in the UK/EU/EEA after 1st September 2018, we will need to see either, your Passport, VISA documents, Residency Permit or ARC Card.
- **For EU/EEA Nationals** – confirmation of your Settled/Pre-Settled status, following your application (application process is explained here: <https://www.gov.uk/settled-status-eu-citizens-families>). Once you have completed your application, you will need to get a "share code" to evidence your status to the College (details can be found here: <https://www.gov.uk/view-prove-immigration-status>)
- **If you are 19 years old or over on the 31 August 2021**, we may be able to assist with the fees for your course. To be eligible for this support you will need be on one of the benefits listed below, and be able to provide evidence, which must be in your name and dated within the last 6 months.
 - Employment Support Allowance
 - Job Seekers Allowance
 - Income Support
 - Housing Benefit
 - Council Tax Reduction (please note, paperwork must show a reduction not just the bill)
 - Child Tax Credit
 - Universal Credit
 - If you are working and earn less than £21,157.50 per year and have a Greater London postcode, please provide documentary evidence (your last three months' payslips or/contract of employment detailing your salary)
 - If you are working and earn less than £17,374.50 per year and live outside the Greater London area, please provide documentary evidence (your last three months' payslips or/contract of employment detailing your salary)

If you do not have evidence of any of the categories listed above, there are other ways we may be able to help, If you receive one of the following additional benefits, we will need to have documentary evidence no more than 6 months old and in your name) and Student Support may be able to assist you with additional costs such as material or exam fees:

- Work Tax Credits & income must be less than £25K
- Pension Credit OR if not on a benefit
- Proof of household income less than £25,000 p/a, via three month's payslips & recent P60.

Fee Information:

- £9.00 for your College ID card (if you are a current student at the College studying in the same area, the fee is waived). This can be paid online via the website following your appointment.

Students who are 19 years and above or overseas, MUST also provide:

- £40.00 Registration Fee

- £1850.00 Tuition Fee

- £145.00 Exam Fee

Depending on your circumstances, you may be exempt from all or some of these fees. We will discuss this with you during your appointment.

More information (for all applicants):

Due to the current situation, we are enrolling students prior to the August result days to ensure the start of year can progress. Following the release of grades we may need to discuss your enrolment and transfer you to an alternative level/programme.

Please ensure you follow Covid-19 guidelines whilst on campus (sanitise hands, wear a face mask, adhere to social distancing etc.) and do not attend if you are displaying Covid-19 symptoms or are required to isolate.
